Terms & Conditions

Registration & retainer fees must be paid at time of registration.

- 2. Medical fees & tuition must be paid prior to the first day of class.
- 3. If you select to pay annually, tuition and all fees are due by the 1st of September of the current academic year.
- 4. If you select to pay per term, tuition & medical fees are due on the first day of nursery for that term.
- 5. The "settling in" procedure is considered an essential part of your child's program. Therefore, full fees apply (i.e. there is no pro-rata fee reduction).
- 6. One time the registration & medical fees are annual fees that are non-refundable and non-transferrable.
- 7. Method of payment: cash, cheque or bank transfer. It is your responsibility to provide a copy of the transfer advise copy. We will not be able to trace payments.
- 8. Late tuition & medical fees: there is a late penalty fee of 25 dirhams for every day that the fees are overdue. A grace period will be given for one week only for applicable late charges.
- 9. If fees have still not been paid at the end of the first week of the term, your child's place can not be guaranteed.
- 10. In the advent of a dishonoured cheque, a bank fee of 100 aed for each returned cheque will incur. In addition, late penalty fees will be levied beyond the due date.
- 11. 25% of the tuition fees are required in advance to secure your child's place for the forthcoming academic year. This is non-refundable, non-transferrable should you choose to withdraw your child from the nursery. However, this 25% will be deducted from the first installment.
- 12. Retainer fees are only returned with written notice 3 months prior to the first day of school.
- 13. If you wish to withdraw said child before the term begins a written notice, 3 months prior to the first day of school, must be given to management. If notice is not given prior to 3 months, all fees and tuition will not be refunded.
- 14. Partial term fees are non-refundable inclusive of reduction in hours, days or said child leaving the nursery.
- 15. Building Blocks Nursery management reserves the right to add, modify and/or amend the above terms from time to time at its' absolute discretion.
- 16. Building Blocks Nursery reserves the right to exclude any child whose fees remain unpaid.
- 17. Building Blocks Nursery reserves the right to withhold any school assessments until all outstanding installments have been settled
- 18. Building Blocks Nursery reserves the right to refuse re-admission unless all previous outstanding balances have been settled and if installments are not paid in the manner stated herein.
- 19. Building Blocks Nursery reserves the right to make any changes and exceptions to the fee policy at our discretion, at any time.
- 20. I waive all claims against the nursery, it's owners and employees and agree to abide by the nursery's policies, term & conditions.
